## Definitions

Nationality	Investor Type	Description
Saudi	<b>Individuals</b>	<b>Saudi Individuals</b> have been classified under 4 categories as defined below:
	- Retail	<b>Retail</b> investors are Saudi individuals , excluding <b>IPIs</b> (see below) and <b>HNWIs</b> .
	- High Net Worth Investors ( <b>HNWIs</b> )	<b>HNWIs</b> are Saudi individuals who have had an average portfolio size of SAR 1m (and above) for the preceding 12 months, excluding <b>IPIs</b> (see below).
	- Individual Professional Investors ( <b>IPIs</b> )	<b>IPIs</b> are Saudi individuals who have had an average portfolio size of SAR 50m (and above) for the preceding 12 months and a portfolio turnover ratio of not more than 4 times annually.
	- Individual DPMs	Saudi individual investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).
	<b>Institutions</b>	<b>Saudi Institutions</b> have been classified under 4 categories as defined below:
	- Corporates	Saudi company with a commercial registration permitting its investment in the stock market .
	- Mutual Funds	A mutual fund managed by an Authorized Person and licensed by the CMA.
	- Government Related Entities ( <b>GREs</b> )	A Government entity or a supranational authority recognized by the CMA.
- Institutional DPMs	Saudi institutional investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).	
GCC	<b>Individuals</b>	<b>GCC natural person</b>
	Institutions	GCC legal person with a commercial registration certificate (corporate or mutual fund), in addition to GCC government entities.
	<b>GCC DPMs</b>	<b>GCC investment account (institutional or individual) in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).</b>
Foreign	SWAP Holders	Authorized Person with the permission to enter into SWAP agreements to transfer the economic benefits of its ownership of shares in Saudi companies listed on the Saudi Stock Exchange to its non-resident foreign clients.
	<b>Foreign Residents</b>	<b>Foreign investors domiciled in the Kingdom with a valid residency permit (Iqama) (excluding GCC nationals).</b>
	QFIs	Qualified Foreign Institutional investors registered with the CMA in accordance with the QFI Rules, to invest in shares listed on the Saudi Stock Exchange.
	<b>Foreign DPMs</b>	<b>Foreign resident investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).</b>
	Strategic Partners	Foreign investors considered founders and partners of Saudi listed companies.

# Weekly Stock Market Ownership and Trading Activity Report

## Highlights

The total value of shares traded for the week ending 27 April 2017 amounted to SAR 15.98 billion, increasing by 4.00% over the previous week; while total stock market capitalization reached SAR 1,627.71 billion at the end of this period, increasing by 0.42% over the previous week.

- ▶ The total value of shares purchased by “Saudi Investors” during this period amounted to SAR 15.06 billion representing 94.22% of total buying activity, and sales of SAR 14.70 billion representing 92.01% of total selling activity. Total ownership of “Saudi Investors” stood at 93.39% of total market capitalization as of 27 April 2017, representing a decrease of 0.04% from the previous week.
- ▶ The total value of shares purchased by “GCC Investors” during this period amounted to SAR 0.425 billion representing 2.66% of total buying activity, and sales of SAR 0.320 billion representing 2.00% of total selling activity. Total ownership of “GCC Investors” stood at 2.38% of total market capitalization as of 27 April 2017, representing a decrease of 0.02% from the previous week.
- ▶ The total value of shares purchased by “Foreign Investors” during this period amounted to SAR 0.499 billion representing 3.12% of total buying activity, and sales of SAR 0.957 billion representing 5.99% of total selling activity. Total ownership of “Foreign Investors” stood at 4.23% of total market capitalization as of 27 April 2017, representing an increase of 0.07% from the previous week.
