

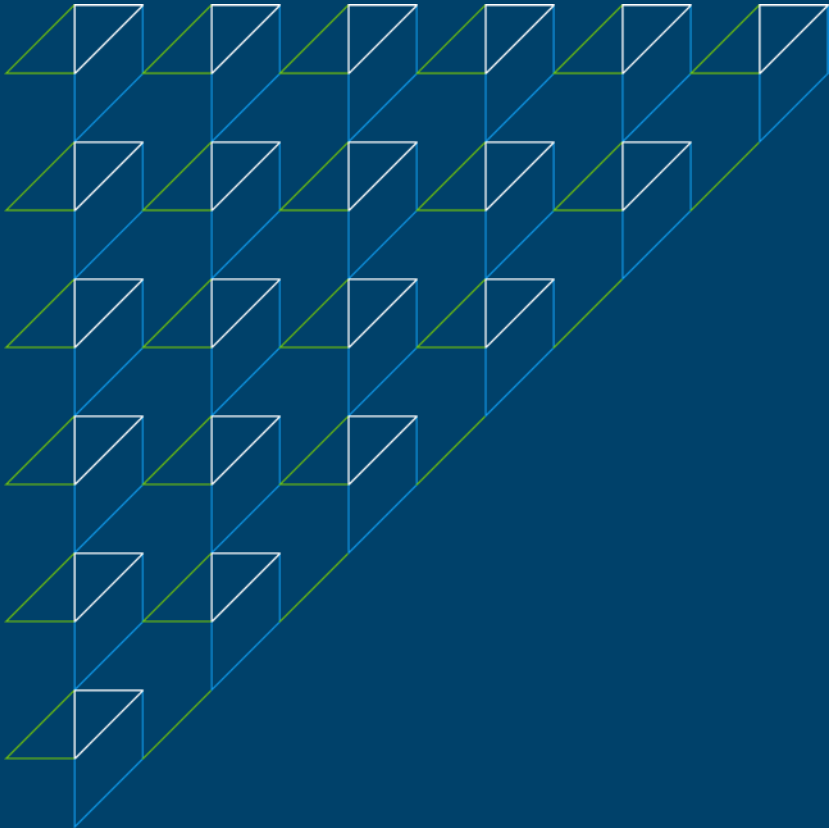

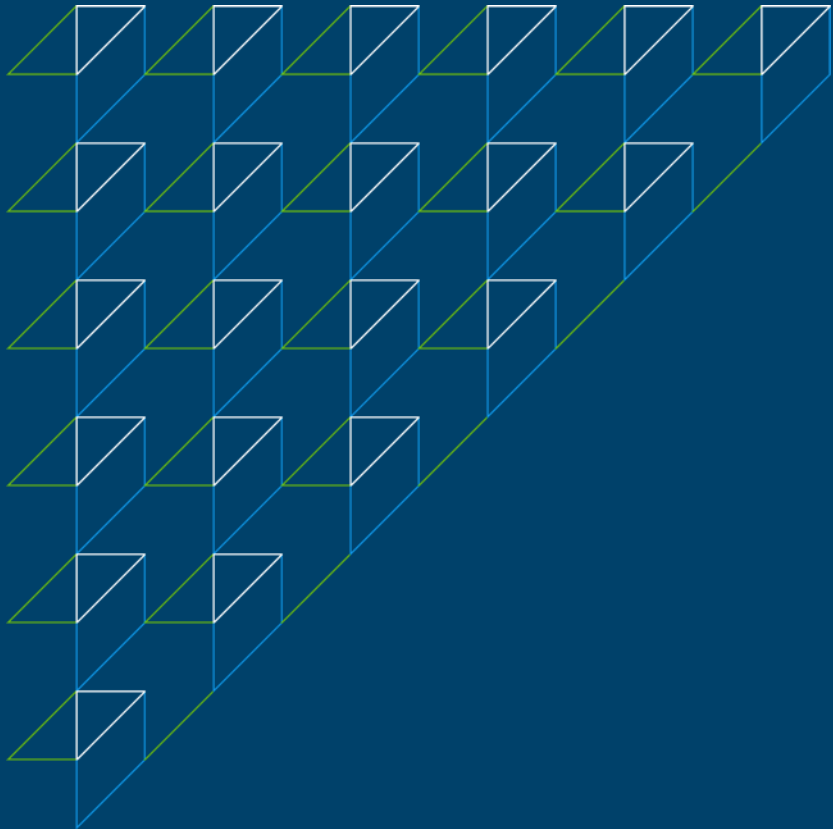

	- High Net Worth Investors ( <b>HNWIs</b> )	<b>HNWIs</b> are Saudi individuals who have had an average portfolio size of SAR 1m (and above) for the preceding 12 months, excluding <b>IPIs</b> (see below).
	- Individual Professional Investors ( <b>IPIs</b> )	<b>IPIs</b> are Saudi individuals who have had an average portfolio size of SAR 50m (and above) for the preceding 12 months and a portfolio turnover ratio of not more than 4 times annually.

	<b>Institutions</b>	<b>Saudi Institutions</b> have been classified under 4 categories as defined below:
	- Corporates	Saudi company with a commercial registration permitting its investment in the stock market .
	- Mutual Funds	A mutual fund managed by an Authorized Person and licensed by the CMA.
- Government Related Entities ( <b>GREs</b> )	A Government entity or a supranational authority recognized by the CMA.	
- Institutional DPMs	Saudi institutional investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).	
GCC	<b>Individuals*</b>	<b>GCC natural person</b>
	Institutions	GCC legal person with a commercial registration certificate (corporate or mutual fund), in addition to GCC government entities.
	<b>GCC DPMs</b>	<b>GCC investment account (institutional or individual) in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).</b>
Foreign	SWAP Holders	Authorized Person with the permission to enter into SWAP agreements to transfer the economic benefits of its ownership of shares in Saudi companies listed on the Saudi Stock Exchange to its non-resident foreign clients.
	<b>Foreign Residents*</b>	<b>Foreign investors domiciled in the Kingdom with a valid residency permit (Iqama) (excluding GCC nationals).</b>
	QFIs	Qualified Foreign Institutional investors registered with the CMA in accordance with the QFI Rules, to invest in shares listed on the Saudi Stock Exchange.
	<b>Foreign DPMs</b>	<b>Foreign resident investment account in which the manager (Authorized Person) makes the buy/sell decisions for its client without referring to the account owner (based on to the agreed terms between them).</b>

# Main Market - Highlights



The total value of shares traded for the month ending 31 July 2018 amounted to SAR 73.21 billion, increasing by 57.69% over the previous month; while total stock market capitalization reached SAR 1,970.62 billion at the end of this period, decreasing by 0.59% over the previous month.

- ▶ The total value of shares purchased by “Saudi Investors” during this period amounted to SAR 67.26 billion representing 91.87% of total buying activity, and sales of SAR 67.85 billion representing 92.69% of total selling activity. Total ownership of “Saudi Investors” stood at 92.81% of total market capitalization as of 31 July 2018, representing a decrease of 0.13% from the previous month.
- ▶ The total value of shares purchased by “GCC Investors” during this period amounted to SAR 2.09 billion representing 2.87% of total buying activity, and sales of SAR 1.34 billion representing 1.84% of total selling activity. Total ownership of “GCC Investors” stood at 2.07% of total market capitalization as of 31 July 2018, representing a 0.00% from the previous month.
- ▶ The total value of shares purchased by “Foreign Investors” during this period amounted to SAR 3.85 billion representing 5.26% of total buying activity, and sales of SAR 4.01 billion representing 5.47% of total selling activity. Total ownership of “Foreign Investors” stood at 5.11% of total market capitalization as of 31 July 2018, representing an increase of 0.12% from the previous month.

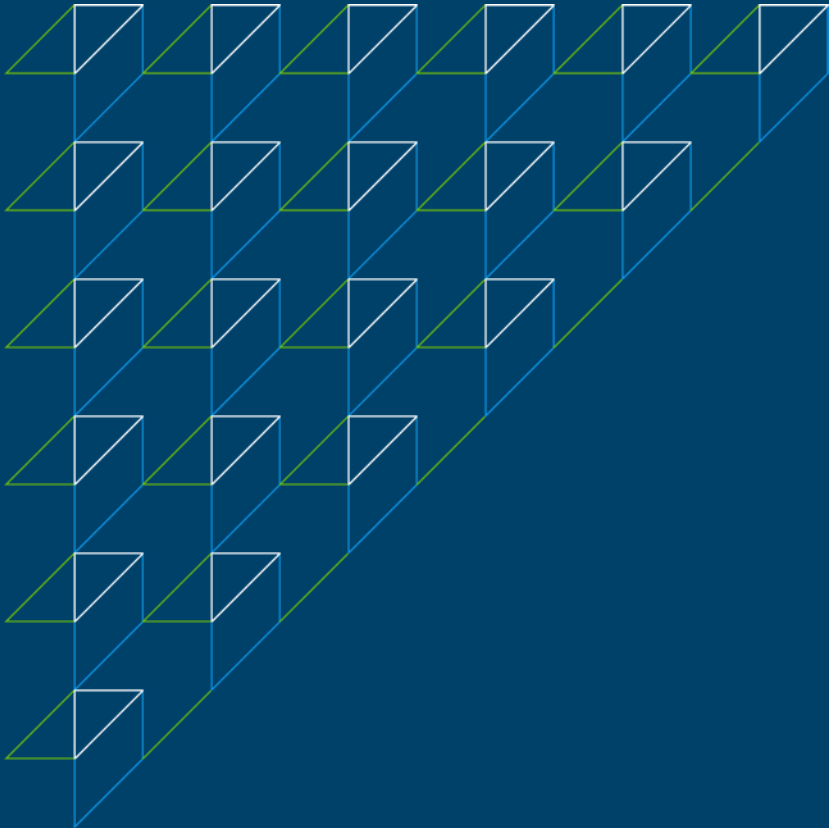

# Nomu-Parallel Market - Highlights

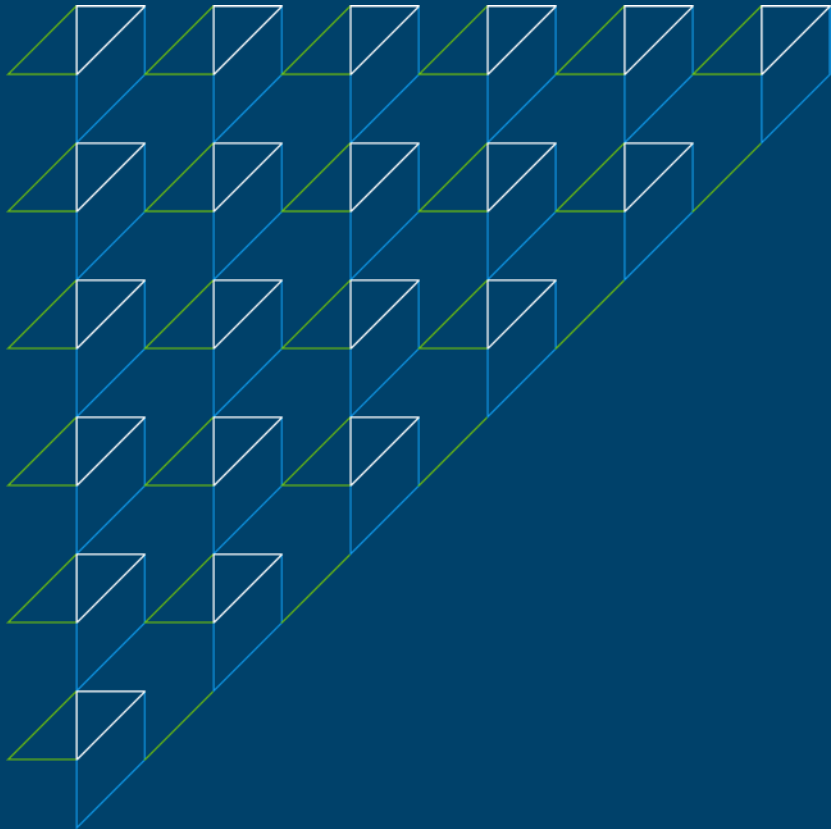


The total value of shares traded for the month ending 31 July 2018 amounted to SAR 45.27 million, increasing by 65.27% over the previous month; while total stock market capitalization reached SAR 2,252.58 million at the end of this period, decreasing by 6.83% over the previous month.



- ▶ The total value of shares purchased by “Saudi Investors” during this period amounted to SAR 41.12 million representing 90.85% of total buying activity, and sales of SAR 44.66 million representing 98.66% of total selling activity. Total ownership of “Saudi Investors” stood at 98.88% of total market capitalization as of 31 July 2018, representing a decrease of 0.21% from the previous month.
- ▶ The total value of shares purchased by “GCC Investors” during this period amounted to SAR 0.00 million representing 0.00% of total buying activity, and sales of SAR 0.02 million representing 0.05% of total selling activity. Total ownership of “GCC Investors” stood at 0.60% of total market capitalization as of 31 July 2018, representing an increase of 0.02% from the previous month.
- ▶ The total value of shares purchased by “Foreign Investors” during this period amounted to SAR 4.14 million representing 9.15% of total buying activity, and sales of SAR 0.58 million representing 1.29% of total selling activity. Total ownership of “Foreign Investors” stood at 0.52% of total market capitalization as of 31 July 2018 representing an increase of 0.18% from the previous month.
