



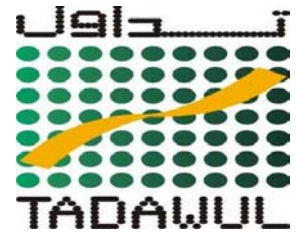

Market Summary

Saudi Stock Exchange (Tadawul) – Annual Statistical Report - 2008

Total Value of Shares Traded reached **SR 1,962.95 billion** and **52.14 million** Transactions were executed during the year 2008

At the end of the year 2008 **Tadawul All Share Index (TASI)** closed at a level of **4,802.99** points compared to **11,038.66** points for the previous year, lost **6,235.67** points (**56.49%**). The highest close level for the index (TASI) during the year was **11,697.01** points as on **12 January 2008**.

The total **Market Capitalization** at the end of the year 2008 reached **SR 924.53 billion** (**US\$ 246.54 billion**), decreasing by **52.50%** as compared to the previous year.

The total **Value of Shares Traded** for the year 2008 reached **SR 1962.95 billion** (**US\$ 523.45 billion**) compared to **SR 2,557.71 billion** (**US\$ 682.06 billion**) for the previous year, a drop of **23.25%**.

* The total number of **Shares Traded** for the year 2008 reached **59.68 billion** compared to **61.73 billion** shares traded during the previous year, decreasing by **3.32%**.

The total number of **Transactions** executed during the year 2008 reached **52.14 million** compared to **65.67 million** trades for the previous year, decreasing by **20.60%**

- **Number of trading days during 2008 were 251 days, against 248 trading days during 2007.**

The **Daily Average Value of Shares Traded** during the year 2008 reached SR 7.82 billion compared to SR 10.31 billion for the previous year, a drop of 24.17%.

The **Daily Average Number of Shares Traded** during the year 2008 reached 237.78 million compared to 248.92 million shares for the previous year, decreasing by 4.48%.

The **Daily Average Number of Transactions** executed during the year 2008 reached 207.71 thousand compared to 264.78 thousand transactions for the previous year, decreasing by 21.55%.

Sectoral Activities:

In term of volume of shares traded, Petrochemical Industries sector was the most active sector during the year 2008, the number of shares traded for the sector reached 14.61 billion shares that represent 24.49% of the total volume traded during the year, followed by Banks & Financial Services sector with a volume of 9.46 billion shares or 15.85% of the total shares traded during the year and the Real Estate Development sector with 6.30 billion shares traded (10.56%) of the total shares traded during the year 2008.

The Petrochemical Industries sector also led the market in term of value of shares traded during the year 2008 amounting to SR 637.69 billion or 32.49% of the total value traded, followed by Banks & Financial Services sector SR.208.98 billion (10.65%) and the Real Estate Development sector SR 163.73 billion or 8.34% of the total value traded.

In term of number of transactions during the year 2008, Petrochemical Industries sector was the most active sector with 9.90 million trades that represent 18.98% of the total transactions executed during the year, followed by the Insurance sector 7.64 million trades (14.65%) and the Industrial Investment sector with 5.55 million trades or 10.65% of the total transactions during the year 2008.

Stock Activities:

With respect to stocks activity during the year 2008, ZAIN KSA led the market in term of number of transactions with 3.96 million trades, followed by Alinma and Petro Rabigh with 3.32 and 2.41 million transactions respectively.

In term of number of shares traded during the year 2008, Alinma topped the list with 7.79 billion shares traded during the year, followed by ZAIN KSA and Saudi Kayan with a volume of 5.39 and 4.88 billion shares respectively.

SABIC was the market leader in term of value of shares traded during the year 2008 and has shown a turnover of SR 174.65 billion. The two other most active stocks were Petro Rabigh and Saudi Kayan that posted value of SR 155.06 billion and SR 120.66 billion respectively.

Initial Public Offerings (IPOs) Summary - 2008

The number of companies offered parts of its shares to public (IPOs) reached **13** during the year 2008. These were **3** companies from the Insurance sector, **3** companies from the Industrial Investment sector, **2** companies from the Petrochemical Industries sector and **1** company from Banks & Financial Services, Retail, Agriculture & Food Industries, Telecommunication & Information Technology and Building & Construction Sector.

The total value for the offered shares reached SR 36.39 billion and the number of shares offered for all IPOs was 2.63 billion shares.

All these companies (**13**) were listed and traded in The Saudi Stock Exchange (Tadawul) during the year 2008, bringing the total number of listed companies to **127**.

By the end of the year 2008 the market capitalization of the offered companies reached SR 66.67 billion that represent **7.21%** of the total market capitalization.

Anaam Co. Stock Trade Resumption

CMA board issued the resolution No.(1-6-2008) dated 27/1/1429 corresp. to 5/2/2008 allowing the trading in the Stock of Anaam International Holding Company effective Wednesday 13/2/1429,corresp. to 20/2/2008 according to the following controls and procedures:

- 1) The company shares will be traded twice a week, specifically on Sunday and Wednesday.
- 2) The trading session starts at 10:00 A.M and the first 15 minutes will be for pre - open (open – order maintenance) during which investors can place their orders (buy and sell).
- 3) The orders and transactions execution period starts at 10:15 A.M and continues for (half an hour) after which trading will be closed and all the existing (non–executed) orders will be cancelled.
- 4) Settlement for all transactions (transfer between buyer and seller) will be finalized after the end of the trading session.
- 5) The stock close price (prior to the suspension) will be adjusted to SR 181.75 and this price will be considered as the base for calculating the minimum and maximum percentages for the stock in the first trading day.
- 6) The fluctuation rate for the trading session will remain the same (+ or - 10%).
- 7) All statistics for the stock trading activities will be published in the reports and publications of the Saudi Stock Exchange (Tadawul).

New Market Structure and Indices

After the new market structure the number of sectors became 15 (instead of 8) and market indices 16 (instead of 9) and is calculated based on the free-floated shares only.

Substantial Shareholdings

The Saudi Stock Exchange (Tadawul) starts displaying the substantial shareholdings of the listed companies on its web-site to enable investors to view all substantial shareholders who own 5% or more of each company's shares according to the record of the Depository Center at Tadawul. Effective 16/08/2008.

Swap Agreements

In its continuance efforts towards the development of the Capital Market, the CMA announced its Board resolution number 2-28-2008 dated 17/8/1429H corresponding to 18/8/2008G that allows Authorized Persons to enter into Swap Agreements with non-resident foreign investors whether institutions or individuals, to transfer the economic benefits of the Saudi Companies' Shares listed on the Saudi Stock Exchange (Tadawul) while Authorized Persons retain the legal ownership of the shares; in accordance with conditions and requirements stated in the said board resolution.

New Tick Size Implementation

The Saudi Stock Exchange (Tadawul) has successfully implemented the new Tick Size with the three bands (below), Effective Saturday 13/09/2008.

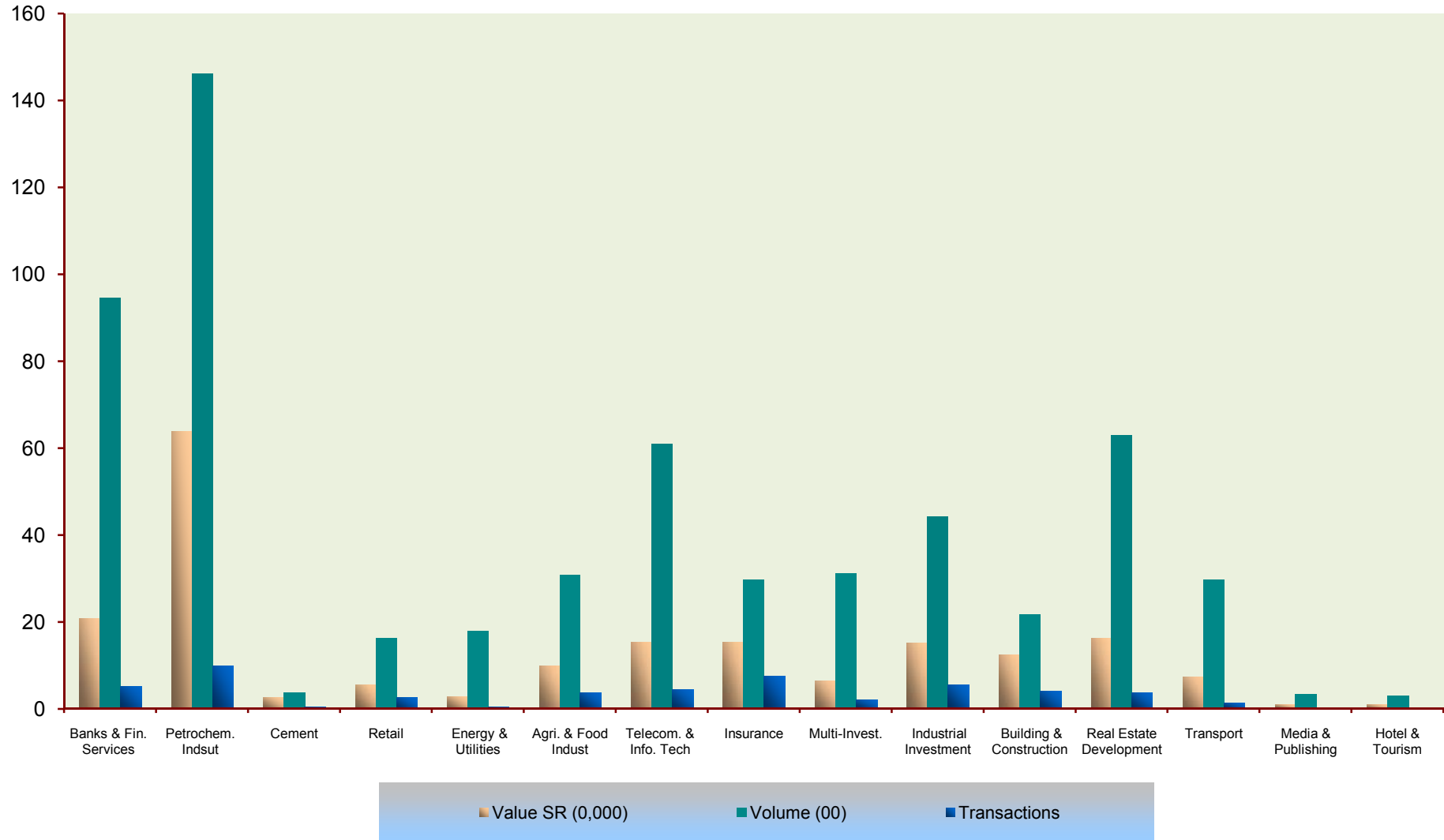

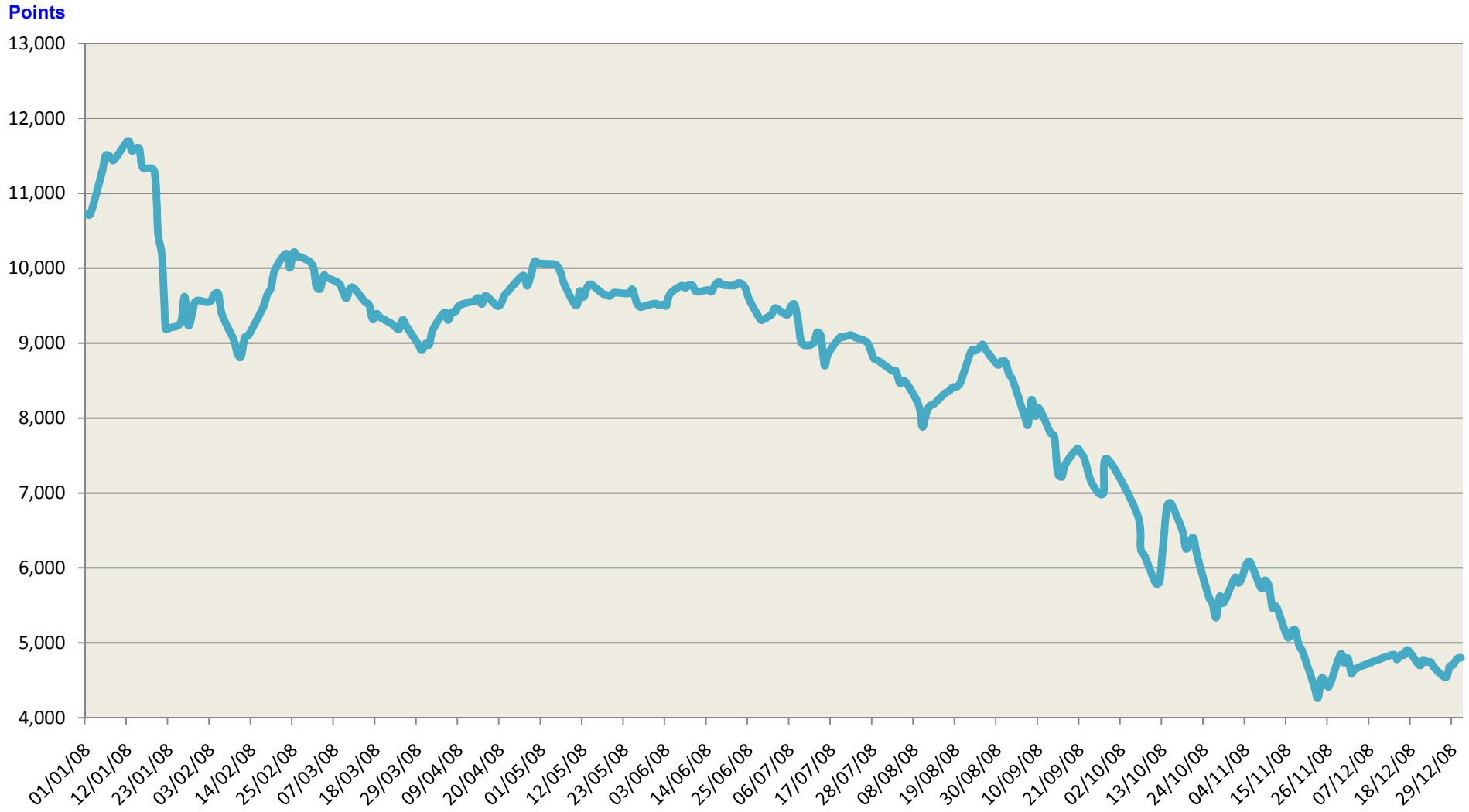


Tadawul All Share Index (TASI) - 4th Q 2008

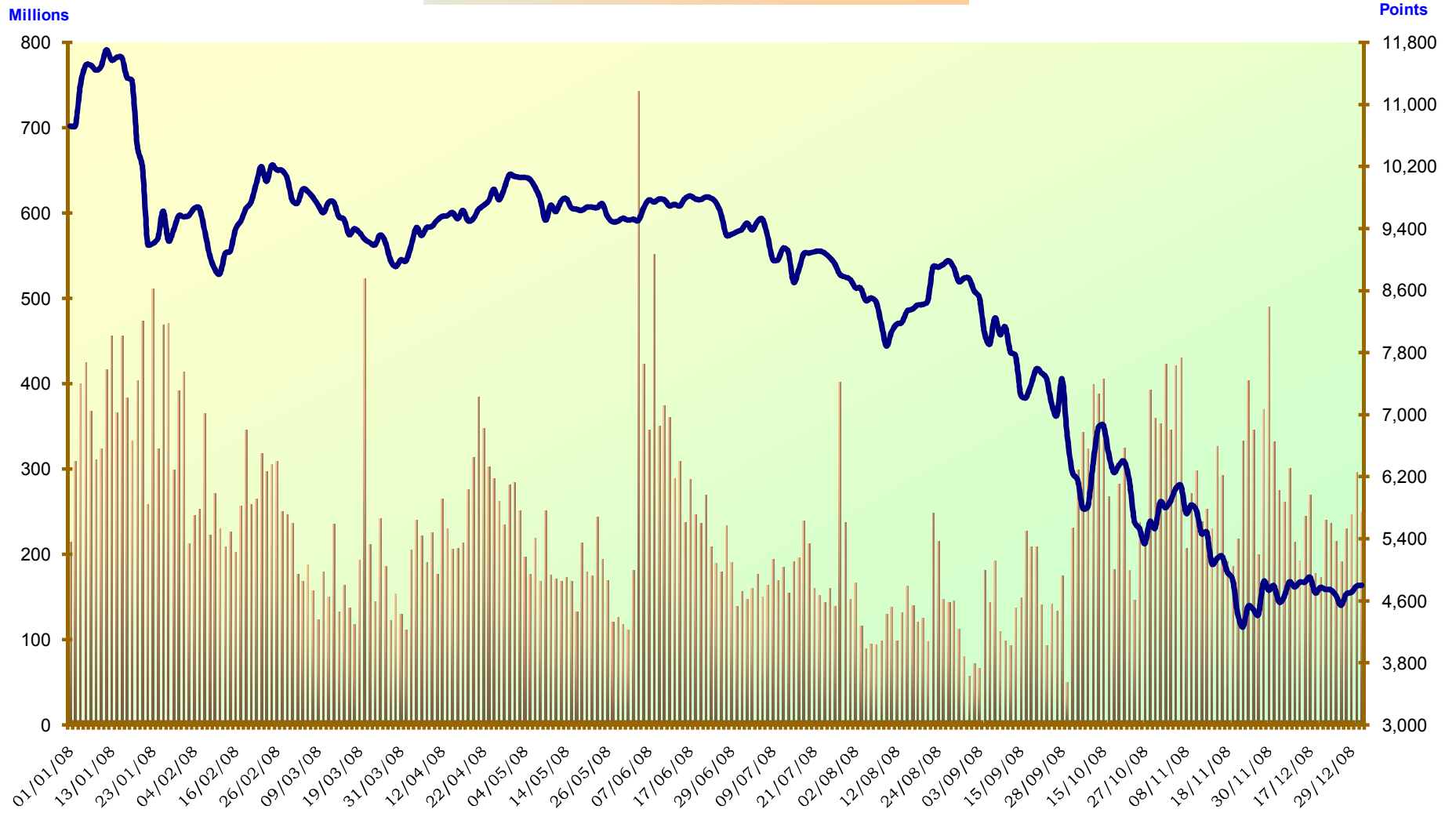

TAdawul All Share Index (TASI) - 2008



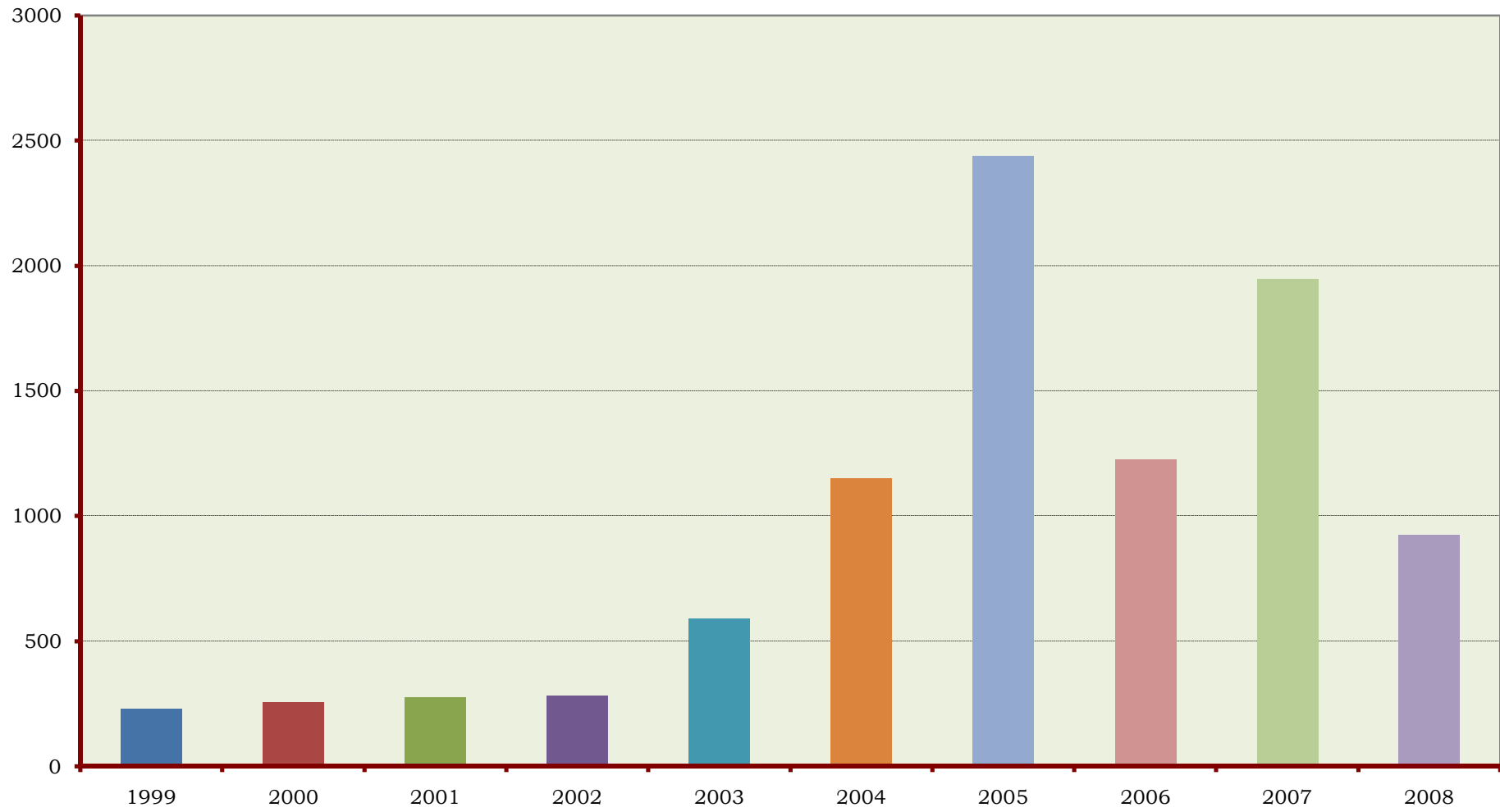
TASI & Volume Traded - 2008

Market Capitalization 1999 - 2008 (SR billion)

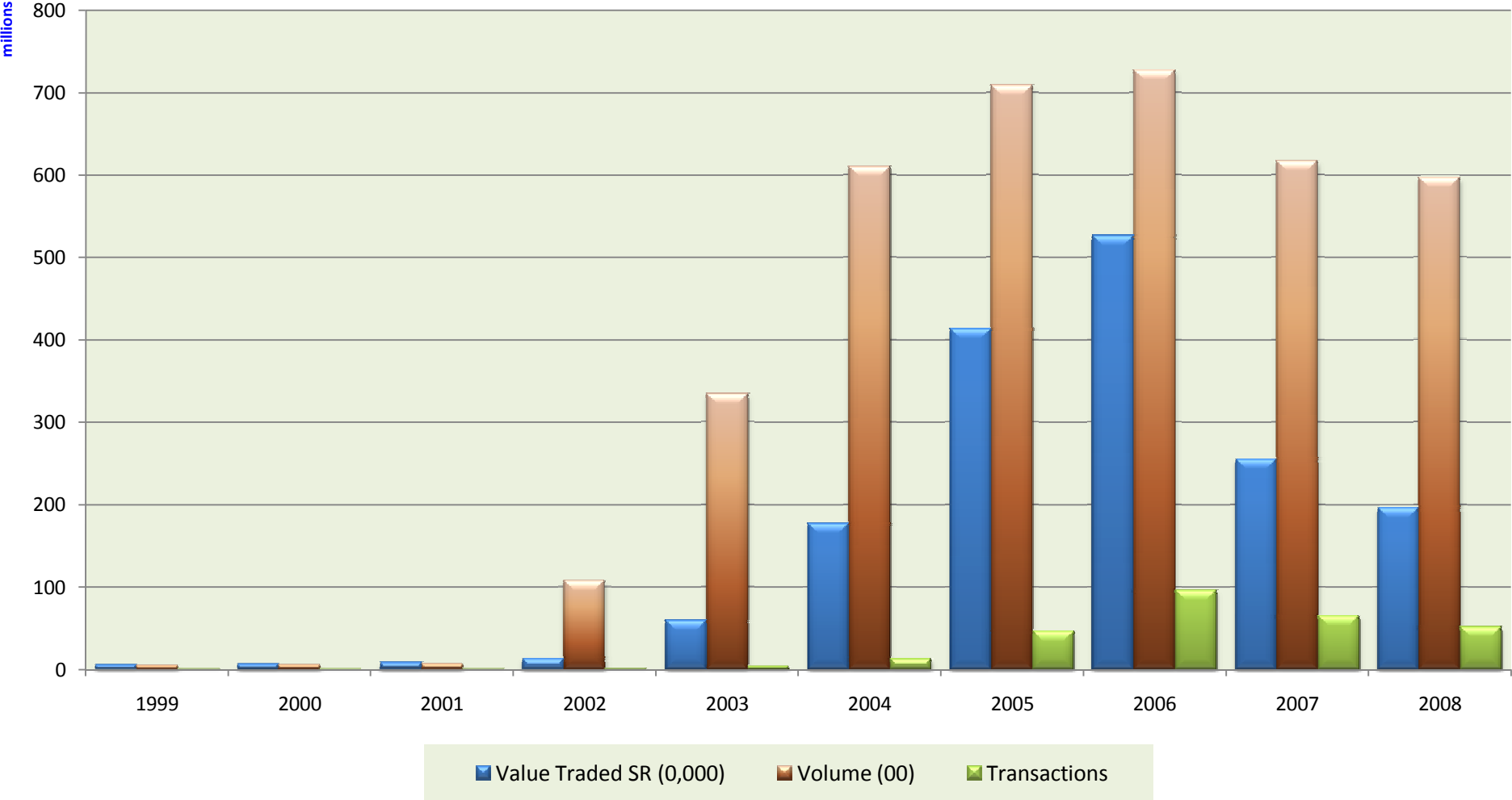
